Additionally, Dan serves as a member of the Supreme Court of Missouri's Commission on Racial and Ethnic Fairness (CREF). The Commission's goal is to examine and review current practices, and to recommend measures to ensure fairness, impartiality, equal access, and full participation for racial and ethnic minorities in the judicial process and in the practice of law.

Throughout his career, Dan has provided board leadership for a number of nonprofit organizations including SchoolSmartKC, the Urban Neighborhood Initiative, the American Jazz Museum, United WE, Cornerstones of Care, the Kansas & Western Missouri Salvation Army, Kansas City CARE Clinic, Don Bosco Community Centers, Schumaker Family Foundation, Swope Health Services, Greater Kansas City Chamber of Commerce and Deerfield Academy Alumni Association.

Dan received his undergraduate degree in Philosophy from Princeton University and earned his J.D. from the University of Kansas.
